

The Association for the Public Defender of Maryland Statement of Privacy.

The Association for the Public Defender of Maryland (APDM) is committed to protecting your privacy. This Statement of Privacy applies to APDM Web site and governs data collection and usage at all APDM sites and services; it does not apply to other online or offline sites, products or services. Please read the APDM Statement of Privacy. APDM is an eCommerce web site. Personal information of all users is collected, used and disclosed as described in this Statement of Privacy.

Collection of your Personal Information

As an e-Commerce Web site, APDM collects personal information, such as your e-mail address, name, home or work address or telephone number. Information collected by APDM is used solely for the purpose of collecting online donations and billing of purchases. APDM does not collect any information about your computer hardware and software.

APDM encourages you to review the privacy statements of Web sites you choose to link to from APDM so that you can understand how those Web sites collect, use and share your information. We are not responsible for the privacy statements or other content on Web sites outside of the APDM Web site.

Use of your Personal Information

APDM and its operational service partners collect and use your personal information to process donations. It is possible that APDM may also use personal information to inform you of other products or services available from APDM and its affiliates. APDM may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

APDM does not sell, rent or lease its customer lists to third parties. We occasionally contract with other companies to provide limited services on our behalf, such as handling the processing and delivery of mailings or assisting with a fundraiser event. We will only provide those companies the personal information they need to deliver the service. They are required to maintain the confidentiality of your information and are prohibited from using that information for any other purpose.

APDM does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

APDM may access and/or disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on APDM or the site; (b) protect and defend the rights or property of APDM including its Web site; or (c) act under exigent circumstances to protect the personal safety of users of APDM or the public.

Personal information collected on this site may be stored and processed in the United States or any other country in which APDM or its affiliates, subsidiaries or agents maintain facilities, and by using this site, you consent to any such transfer of information outside of your country. APDM abides by the safe harbor framework as set forth by the U.S. Department of Commerce regarding the collection, use, and retention of data.

Security of your Personal Information

APDM is committed to protecting the security of your personal information. We use a variety of security technologies and procedures to help protect your personal information from unauthorized access, use, or disclosure. For example, we store the personal information you provide on computer systems with limited access that are located in controlled facilities. When we transmit highly confidential information (such as a credit card number) over the Internet, we protect it through encryption throughout.

Changes to this Statement

APDM will occasionally update this Statement of Privacy to reflect company and customer feedback. If there are material changes to this Statement or in how APDM will use your personal information, APDM will prominently post such changes prior to implementing the change. APDM encourages you to periodically review this Statement to be informed of how APDM is protecting your information.
